   More information on enrollments has been requested regarding this replacement.
- 2. Communications (Rippe) 1986-87
  The leave of absence for Mrs. Rippe has been extended through May, 1986. It is recommended that we advertise for a tenure track position. If Mrs. Rippe does opt to return in 1986-87, the announcement would be rescinded.
- 3. LAC/Tutorial/Biology (Matsui) 1986-87
  A study is being conducted to determine if the
  LAC/Tutorial Director can be changed to a classified
  position. If this change is made, the replacement funds
  will be available for funding a new position.

- 4. BOE (Green) 1986-87 A study is being made relative to making this a classified LTA position.
- C. Members agreed that much of the problem in these impacted areas stems from the addition of the matriculation program without any increase in staff for the assessment of all incoming students and the increased number of classes required to serve those students.

To approve the recommendation of the Instruction Office to fill three new/replacement positions: English (Composition/Literature), Math, and English

Members expressed disappointment and frustration in learning that only \$17,500 of the \$500,000 Lottery monies given to SBCC will be used to alleviate the critical need for certificated personnel.
